**Payment**

**Collection of Lots**

Lots must be paid for and collected from the sale venue by 11am on Sunday 4<sup>th</sup> May. Bonhams & Butterfields will be accepting payment after the auction on Saturday evening until 7pm and between 8:30 am – 11am on Sunday. Lots are at the buyer's risk from the fall of the hammer. It is strongly advisable that overseas purchasers and absentee bidders make arrangements regarding collections with Bonhams & Butterfields in advance of the sale.

All uncollected Motorcycles & Memorabilia purchased lots will be transferred to the Bonhams & Butterfields San Francisco location for collection by buyer or third party agent. Our shipping department can ship most memorabilia lots, but cannot ship motor vehicles. These lots will be available for collection starting Monday 5<sup>th</sup> May after 10am. **Removal and Storage**
