#### **Payment**

#### **Collection of Lots**

**Motorcar and Automobilia** lots must be paid for and collected from the sale venue by 12pm on Sunday August 17th.

**Jewelry and Watch** lots must be paid for and collected from the sale venue by 3pm on Saturday August 16th.

Bonhams & Butterfields will be accepting payment after the auction on:

Friday August 15th in the evening until 6pm

Saturday August 16th from 9am until 5pm (3pm final hour for Jewelry and Watches)

Sunday August 17th from 9am until 12pm (for Motorcars and Automobilia only)

**Uncollected Motorcar** lots will be transported to a storage facility at the buyer's risk and expense. Uplift charges will be \$500.00 per vehicle with additional storage charges as applied by the storage facility.

**Uncollected Automobilia** lots will be transferred to the Bonhams & Butterfields San Francisco location for shipping or collection by buyer or third party agent.
